## Job description

- Coordinate ad-hoc regulatory requests and contribute to statutory and regulatory audits by handling audit enquiries;
- Provide support with regards to projects and the coordination of the bank's external audit;

- Keep abreast of regulatory developments and reporting obligations of the Bank;
- Assistance in analysing and interpreting data from regulations;
- Form a close working relationship with the Financial Controller, CFO and other Senior Executives and Non-Executives;
- Assistance in the testing and migration requirements of new systems.
